- 2. Increase income
- 3. Spend savings
- 4. By a combination of the above 3 ways.

Since there are 30 members present, 16 votes are needed to pass the motion to approve the Budget as drafted. Lorna Turner made a motion to accept the Budget, Dot Battle seconded. Motion failed.

Cathy asked the membership to propose specific amendments using the referenced 4 ways to change the budget.

- Amendment to reduce Membership by \$600.00 and to be added to Philanthropy budget: PASS – Ayes 18
- Amendment to reduce large line items: Leadership and Membership by 30% and to be added to Philanthropy budget: FAIL Ayes 4
- Amendment to reduce 5th/6th District reps by \$50.00 and to be added to Philanthropy budget: PASS Ayes 19
- Amendment to reduce Arts and Culture to \$100.00: FAIL Ayes 1
- Amendment to increase Civic Engagement to \$400.00 for specific gifts to First responders: FAIL – Ayes 4
- Amendment to increase transfer \$90.00 Communications/Public Relations from Membership: PASS – Ayes 16
- Amendment to increase Philanthropy budget by \$4000.00 by using savings: FAIL Ayes 4

Julie Tillotson made a motion to vote to approve budget as amended. Lorna Turner seconded. Motion carried in accordance with the by-laws. Ayes 18
